APPLICATION AND SAFETY FOR TOXIC GASES IN INDUSTRY AND LIFE - Nov. 28th, 2025

As part of its 2025 project program, AIGA Vietnam, in cooperation with the VINACHEMIA, organized Webinar #04 on 28 November 2025.

- The webinar aimed to share knowledge on the properties and risks of **SO₂**, **H₂S** and **CO**, their health impacts, safety measures in storage, transportation and use, as well as lessons learned from real incidents.
- The webinar was officially opened by **Mr. Erik Mota**, Chairman of AIGA VN
- The event attracted **more than 97 participants** from AIGA Vietnam member companies, AIGA Asia, and local companies.

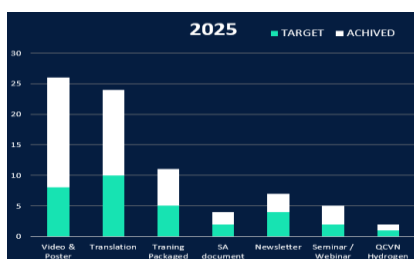
